# CONSIDERATION OF RESOLUTION NO. 01-20, SERIES OF 2020

A RESOLUTION BY THE BOARD OF COMMISSIONERS OF THE DILLON URBAN RENEWAL AUTHORITY, AUTHORIZING THE DILLON URBAN RENEWAL AUTHORITY TO ENTER INTO A PROPERTY TAX INCREMENT REBATE AGREEMENT WITH UPTOWN 240 LLC, A COLORADO LIMITED LIABILITY COMPANY; AUTHORIZING AND DIRECTING THE APPROPRIATE TOWN OFFICERS TO SIGN THE NECESSARY AGREEMENT.

Nathan Johnson explained that this resolution approves a property tax increment rebate agreement with Uptown 240 to reimburse the developers for public improvements and mitigation of blight over time using the property tax increment generated from the project.
