<u>CONSIDERATION OF RESOLUTION NO. 03-21, SERIES OF 2021</u> A RESOLUTION APPROVING A FIRST AMENDMENT TO AMENDED AND RESTATED PROPERTY TAX INCREMENT REBATE AGREEMENT BETWEEN DURA AND DILLON HOTEL ASSOCIATES, LLC.

Carri McDonnell, Finance Director, stated the original Property Tax Increment Rebate Agreement with Dillon Hotel Associates (dba Homewood Suites) was approved on 7/3/2018. The original expiration date was 12/31/20 and in November 2020, DURA extended the deadline to May 1, 2021 due to the delays associated with COVID. The TIF agreement was amended and restated on April 8, 2021 to extend the deadline to August 31, 2021 and provide clarification on how the tax increment financing will be distributed.

The developer requested an amendment to extend the August 31, 2021 deadline due to supply chain issues.

Ms. McDonnell explained this resolution approves an amendment to the TIF Agreement that extends the deadline to December 31, 2021.

Commissioner Kaminski moved to approve DURA Resolution No. 03-21, Series of 2021. Commissioner Milroy seconded the motion which passed unanimously upon roll call vote.
