Subject: December 2015 Police Department Status Report

## **Incidents:**

On December 21<sup>st</sup>, at approximately 11:53 PM, Officer Nauroth and Officer Taft were dispatched to the area of Tenderfoot St. and Hwy 6, for a motor vehicle accident. Upon arrival they found an unoccupied van high centered over a damaged guard rail and on top of a destroyed pine tree. A few minutes later a male drove up and said he was looking for his girlfriend who was in the van, and said she may be headed to Summit Cove.

Deputy Slutzky followed footprints in the snow from the scene of the accident all the way to the 200 block on Cove Blvd, where he made contact with 3 individuals walking on the roadway. The female driver was identified and arrested for DUI; she blew a .128 on the breathalyzer.

On December 24<sup>th</sup>, at approximately 1:45 AM dispatch aired a fight in progress outside the Lake Dillon Tavern. When Officer Denney arrived a person yelled "he's over there". Officer Denney pulled into the parking lot on the west side of Lake Dillon Tavern and observed a male getting into a car. The male disregarded Officer Denney's orders, got into his car, backed out of his parking spot, and accelerate toward Officer Denney. Due to the ice, the car was unable to gain speed and Officer Denney was able to get out of the way of the car.

The car turned onto LaBonte, ran through the stop sign at Lake Dillon Dr., went the wrong way around the traffic circle on the Dam Rd., and then turned left onto Hwy 6 driving westbound in the eastbound lane at approximately 70 mph, against on-coming traffic. At Stephen's Way the car lost control and hit a light pole.

While the car was stuck in the snow Officer Denney and Officer Taft approached the car. Officer Denney broke out the heavily tinted passenger side window with his baton. The car broke free of the snow bank and continued n/b in the s/b lanes of Hwy 6 to 3<sup>rd</sup> St., where it struck a CSP vehicle and a Silverthorne PD vehicle. The driver attempted to hit Officer Denney's car, but he was able to avoid the collision. The car then lost control and went into a ditch.

The driver was contacted and arrested on multiple charges including DUI, and felony eluding.

On December 26<sup>th</sup>, at approximately 9:20 PM, Officer Nance and Sgt. Crutchley were dispatched to an address on Ensign Dr. for a domestic violence call involving a gun, a knife, and a drinking glass. After arguing all day in front of their son and daughter, the husband took a knife from the kitchen, said he wanted to end it and handed it to the wife. The wife then slashed the knife at the husband,

who dodged the attack. In her continued rage, the wife smashed a drinking glass over the husband's head. The adult son called the police, who arrived to find the husband bleeding from the head wound. The wife was arrested for domestic violence and felony assault. The family, from out of state, had rented the residence for the holidays. Because alcohol was a factor in the incident, a pistol was taken for safekeeping.

## **Equipment:**

The following equipment was ordered to complete the 2015 budget:

Three Tasers

Department owned lethal shotguns were modified into less-lethal shotguns - orange stocks and fore grips added. Training for the department to be conducted in 2016.

Five laptops (Mobile Data Computers – MDCs) arrived and were put into service so all officers have their own assigned computer. Desktop computers will be phased out and replaced with MDCs docked in the office.

## **Stats:**

With the exception of vehicle tows, the stats appear to be in line with the previous months and the influx of people for the holidays. The rise in the number of vehicle tows is mostly due to tows associated arrests of the driver and vehicles operated without insurance. Officers are being encouraged to find alternative methods of dealing with these issues, other than towing.

**RE:** Project Update

The Public Works Department is responsible for eight divisions within the Town of Dillon including: Engineering, Community Development & Planning, Water Treatment & Distribution, Sewer Collection, Street Maintenance, Fleet Maintenance, Grounds Maintenance, and Facility Maintenance.

The following list provides a general synopsis of the current activities in the Public Works Department.

# **Engineering**

- Staff is working on the preliminary Lodgepole Street design for 2016.
- Working with Architect on developing the Amphitheater Masterplan.
- Staff is conducting a utility analysis of the Amphitheater area utilities.
- Staff met with XCEL Energy about scope and pricing for the 2016 undergrounding project.
- Began analysis of Dillon Ridge offsite detention ponds.
- Processing the close-out of 2015 contracts.

## **Community Development/Planning**

- Staff continues working on amphitheater conceptual design work.
- Review of marijuana regulations, forms, and renewal information for 2016.
- Continued Core Area development discussions.
- Staff has been working on substantial updates and tasks in the GIS software.
- Processing several Class III and Class IV Development Applications:
  - Level III Adopt new condo map at Lake Dillon Condominiums.
  - Level IV Dillon Gateway Planned Unit Development (PUD) and a concurrent Level III conditional use permit for a ground floor residential unit.
  - Level III Conditional Use Permit for a Residential Unit at 707 E. Anemone Trail (Red Mountain Plaza).
- Issued several development permits for roofing and remodels. Notable projects Include:
  - City Market has submitted plans for an internal remodel to update the layout and feel of the store.
  - Issued Grading and Excavation permit to repair water leak at the City Market gas station kiosk.

#### Water & Sewer

- Staff began filling the new 1.5 MG Water Storage Tank on December 16<sup>th</sup>. Bacteriological testing will be conducted and the tank will be placed in service by the end of December.
- Annual testing of the Dillon/Silverthorne Interconnect Pump Station was performed on December 3<sup>rd</sup>. Station performed as designed without any issues. This station connects the Dillon and Silverthorne water distribution systems, and is design to provide water to either district in the event of an emergency.
- Leak Detection City Market repaired leak at the gas station property. This leak was found during a leak survey this fall. This service line break was leaking at a rate of 25 gpm.
- Cross connection/Backflow program: 29 of 255 device not completed for 2015. 5 devices were off because of construction = total of 18 of 250 (93% completion).

# **Streets, Buildings & Grounds**

- Staff continues to conduct snow and ice control operations throughout the Town.
- The Town Park Phase I Design Project continues. The consulting team, town staff and PRAC members met with Dillon Valley Elementary and Dillon preschools to gather input for the new playground facilities. This outreach effort was well received and was the first of two public meetings planned for the project. The next public meeting will be held in January and is intended to gather input from Dillon residents.
- Staff continues to work on minor building and facility projects. Staff is now modifying existing drop ceilings with noise attenuating ceiling tiles.
