**RE:** Project Update

The Public Works Department is responsible for eight divisions within the Town of Dillon including: Engineering, Community Development & Planning, Water Treatment & Distribution, Sewer Collection, Street Maintenance, Fleet Maintenance, Grounds Maintenance, and Facility Maintenance.

The following list provides a general synopsis of the current activities in the Public Works Department.

#### **Engineering**

- Working on grading design for the Amphitheater Master Plan.
- Developing 2016 recreation path repair program.
- Working on new parcel map for the Town GIS.

#### **Community Development/Planning**

- Working with applicant on Dillon Gateway project.
- Staff continues working on Amphitheater conceptual design work.
- Review of marijuana regulations, forms, and renewal information for 2016.
- Continued Core Area development discussions.
- Processed several small remodel applications.
- General organization for start of 2016 record year.

#### Water & Sewer

- The new 1.5 MG water storage tank is substantially complete and in service. Final completion
  tasks will be completed in the spring and will include final grading and seeding, security fencing,
  and drainage improvements.
- Staff is preparing to replace 20 year old equipment and communication system in the Marina Lift Station.
- Staff has begun the installation of jib crane with hoist and trolley in the Water Plant.
- Staff has completed GIS training and has begun updating sewer collection system data.
- Lead and Copper Town has been allowed to reduce sample collection from 20 samples every 6 months to 10 samples per year. Corrosion Control System continues to operate as designed.

#### **Streets, Buildings & Grounds**

- Staff continues to conduct snow and ice control operations throughout the Town.
- The Town Park Phase I Design Project continues. A public meeting was held on January 28<sup>th</sup> to gather input on the design. The meeting was well attended and the overall comments were positive. The consultants will now begin developing the plans for the 60% design review.
- Staff continues to work on minor building and facility projects. Staff is now modifying existing drop ceilings with noise attenuating ceiling tiles.
- The Public Works Department has agreed to sponsor a local Boy Scout who is attempting to get his Eagle Scout designation. The Scout will be working trail improvements and signage at the Dillon Nature Preserve.

Subject: January 2016 Police Department Status Report

#### **Incidents:**

Sgt. White was called to a local hotel for a welfare check on a guest that had not checked out. Upon entering the room Sgt. White found a note taped to the bathroom door that said, "Stay Out Poisonous Gas". Sgt. White notified Lake Dillon Fire and Rescue and activated the HazMat Team. The guest was found deceased in the room from a "chemically assisted suicide. This was only the second such incident in Summit County.

Officer Scherr and Sgt. White have been working with an elderly resident who was being harassed telephonically by several scammers operating outside the US. Officer Scherr was able to work the Century Link to get the telephone numbers blocked and there have been no further issues since. Sgt. White is continuing to work with the resident and Adult Services to address some other issues.

#### **Staffing:**

All positions are currently filled. The newly created Police Officer II position has been posted and letters of interest are due January 29th. A panel will be used to assist in making the selection.

#### **Training:**

24 hour Standardized Field Sobriety Testing certification - White

20 hour SWAT training: Nance

\* Officer Nance received a thank you letter from Chief Haynes in Breckenridge for his assistance conducting a Patrol Rifle Class for both Breckenridge PD and Dillon PD.

#### **Equipment:**

The 2016 patrol vehicle has been ordered.

#### **Stats:**

All the stats appear to be in line with the previous months.

#### **Miscellaneous:**

Sgt. Crutchley worked on the LEAF (Law Enforcement Assistance Fund) Grant and received \$12,000 for DUI enforcement overtime shifts. He also worked on the HVE (High Visibility Enforcement) Grant and received \$5,000 for January thru June. This grant is used to cover overtime for traffic enforcement during specified times/events such as Super Bowl weekend, Prom, and St Patrick's Day.
