Re: Operations Update

On December 31, 2015 slip renewal invoices were sent out to 2015 Marina customers. All 2015 Marina slip and mooring customers who pay their fees by February 1st 2016 receive a 2% discount. If payment is not received by March 1st 2016 the Marina will open up the remaining slips to the people on the waiting list. Due to the number of people currently on the waiting list, we anticipate being at full capacity for slip rentals in 2016. Marina income is ahead of last year by approximately 10% from 2015.

At the end of January, Shannon and I attended The International Marina and Boat Yard Conference. Because of the small size of the Dillon Marina it is vital that we make a personal positive impression with these suppliers because we are just not big enough to get their attention with dollar volume alone. I met with Bruce Lunde and Dan Williams about the next phase of the marina master plan implementation. It may be time to think about updating the master plan for the marina in the future.

The docks for the marina slip expansion in spring of 2016 have been ordered.

Shannon is processing slip renewals, working on the marina office and store. The electronic slip renewal is working well. Clothing designs and logo artwork for the retail store are being developed this month and we are researching new items to add to our merchandise based on customer requests.

Ice fishing interest has been very high at the marina this winter with lots of fish being caught. We have installed a port-a-let at the marina ramp area for them to use as well as all the guests just walking around the area.

The new rental pontoon boat is in the process of being ordered upon shipment of the engine and we will rig boat in May.

Most people do not realize how busy we are during the winter months.
