RE: Project Update

The Public Works Department is responsible for eight divisions within the Town of Dillon including: Engineering, Community Development & Planning, Water Treatment & Distribution, Sewer Collection, Street Maintenance, Fleet Maintenance, Grounds Maintenance, and Facility Maintenance.

The following list provides a general synopsis of the current activities in the Public Works Department.

Engineering

- Completed initial design for Lodgepole Street and Lake Dillon Drive intersection.
- Completed grading design and 3D model for the Amphitheater Master Plan.
- Finalizing 2016 work plan.

Community Development/Planning

- Staff is preparing a grant application with the Summit County Wildfire Council for a forestry
 mitigation project at the Disc Golf Course and Dillon Nature Preserve. Work for both areas will
 include standing dead and hazard tree removal.
- Staff continues working on Amphitheater conceptual design work with our design consultant.
- Staff working to develop vaping ordinance.
- Continued Core Area development discussions.
- · Continued general organization for start of 2016 record year.

Water & Sewer

- Staff is preparing for final completion tasks related to the new water storage tank project. Final completion tasks will be completed in the spring and will include final grading and seeding, security fencing, and drainage improvements.
- Repairs and upgrades to the Marina Lift Station have been finalized. Work to the station will be completed in April.
- Staff has completed the installation of jib crane in the Water Plant. This crane was installed to facilitate pump and motor removal as well as other overhead lifting operations.
- Staff continues updating sewer collection system data in GIS.

Streets, Buildings & Grounds

• Staff continues to conduct snow and ice control operations throughout the Town.

- The Town Park Phase I Design Project continues. Design team is finalizing the overall site design and has begun preparing design/construction documents. Final design documents will be reviewed by DPRAC in May and presented to Council early in June.
- Staff continues to work on minor building and facility projects. Staff is now modifying existing drop ceilings with noise attenuating ceiling tiles. Staff is also preparing a request for proposals to remodel the 3rd floor/Council room at Town Hall.
- Staff is finalizing the 2016 Dillon Nature Preserve Improvement Projects. Projects will include standing dead removal, trail improvements and signage, improved ADA parking and recreation path access, rest/picnic shelters, and improved highway signage.

Subject: February 2016 Police Department Status Report

Incidents:

On February 20th, Officer Denney wrote in his pass-down log:

5 AM a guy was sitting in his car down at Lower Yacht illegally parked. I asked him what he was doing...he had been waiting in his car for three hours for someone to move so he could get a parking spot.

On the afternoon of February 24th an off-duty CSP Trooper notified dispatch he had just witnessed a man tuck a pistol into his waistband and go into Sports Authority. Officers responded and found the man at the gun counter holding a shotgun. The man was contacted and the pistol in his waistband was secured. The young man mistakenly believed carrying the pistol in his waistband, underneath his coat, was considered "open carry", making it legal. After a lesson on open carry vs. concealed carry (permit required) the pistol was placed in the trunk of the man's car and he was released.

On February 25th, Sgt. Crutchley and Officer Scherr responded to a medical call at City Market – female passing out. Upon arrival it was determined the woman was intoxicated. The woman had parked in a handicapped parking space because her ankle hurt. Officer Scherr asked her multiple times if he could move her car to another space, but she refused to allow it. She said she would get her neighbor to driver her back to get the car. Those comments lead to her involuntary detox hold and her car was towed. She blew a 0.243 on a portable breath tester.
