**RE:** Project Update

The Public Works Department is responsible for eight divisions within the Town of Dillon including: Engineering, Community Development & Planning, Water Treatment & Distribution, Sewer Collection, Street Maintenance, Fleet Maintenance, Grounds Maintenance, and Facility Maintenance.

The following list provides a general synopsis of the current activities in the Public Works Department.

#### **Engineering**

- Working on construction documents for the Marina Stair Project.
- Working on the path addition plans to accommodate a fire truck down to the Amphitheater.
- Working on civil plans for fall Amphitheater design work.
- Creating a GIS layer for Storm Sewer pipes, manhole and inlets.
- Began studying the capacity of the Dillon Ridge Detention Ponds.

#### **Community Development/Planning**

- The Town was awarded a grant from the Summit County Wildfire Council for a forestry
  mitigation project at the Disc Golf Course. Work includes standing dead and hazard tree
  removal. This work is necessary prior to additional disc golf improvements.
- Processed small banner permits and permits for remodeling projects.
- Dillon Gateway revised architecture is complete and will be reviewed at the July 6<sup>th</sup> Planning and Zoning Commission meeting.

#### Water & Sewer

- Second fill completed at the Old Dillon Reservoir.
- Final site work at the new water storage tank is underway and will be completed by the end of July.
- Annual Sewer Collection System cleaning and inspection will begin in July.
- Annual Consumer Confidence Report completed and published.
- Annual hydrant flushing, valve maintenance, meter testing and backflow device testing operations are underway.
- Continued plant maintenance and filter module replacement.
- Staff continues updating water and sewer system data in GIS.

#### **Streets, Buildings & Grounds**

- The Eagle Scout Nature Preserve Project is underway. All trails have been surveyed using GPS and new trail markers have been ordered. Installation of the new markers will occur July 28<sup>th</sup>.
- The new Nature Preserve Trailhead Project has begun which will link the parking area with the Meadow Trail below Summerwood. The work is being performed by volunteers working with the Summit County Open Space Department.
- Our annual flower order has arrived and crews are working quickly to plant materials throughout the Town.
- The dumpster enclosure at Town Hall has been reinstalled following the parking lot expansion.
- Capital improvement projects will begin at the Disc Golf Course starting July 8<sup>th</sup>. Work will include the installation of alternate basket location sleeves and the installation of fairway signage posts. The fairway signs will be completed this fall.
- Design work is being completed for an improved Disc Golf parking area. This plan will be reviewed by the Town and Summit County as a possible collaborative project in 2017.
- Staff have begun all roadway maintenance and striping.
- The engineering design for the new Cemetery Road alignment is in process.
- Staff continues to work on minor building and facility projects.

Subject: June 2016 Police Department Status Report

#### **Incidents:**

We received a Thank You from Chief Minor after Officer Nauroth responded to a robbery call and assisted Chief Minor in apprehending the suspect. A Domino's Pizza employee entered the store and stole money from the register and the tip jar. When he was confronted, the male assaulted another employee and fled. A perimeter was established by officers, deputies, and troopers. The suspect was taken into custody without incident and was subsequently charged with Robbery, Theft, and 2<sup>nd</sup> Degree Assault.

On June 30, Officer Denney responded to assist Silverthorne PD on a weapons call at one of the Outlet Stores. A witness reported he saw the suspect reach down to a pistol in his waistband and he then heard the pistol being cocked. Officer Denney was first on scene and saw the male talking on his phone with a pistol clearly sticking out of his waistband. As the male began to walk away, Officer Denney confronted him. The male did not comply with Officer Denney's orders so Officer Denney forced him to the ground. Other officers arrived and Officer Denney removed the pistol and several throwing-knives from the male's waistband. The male was arrested by Silverthorne PD for being in possession of a handgun while intoxicated.

#### Staffing:

Officer Clayton Denney is relocating to Michigan; his last day will be July 13th.

Officer Jason Taft is still on light-duty due to a non-work related injury. Ryan Rice is still in the academy.

#### Training:

All sworn members of the department completed the following POST mandatory training (on-line)

Anti-Bias Training For Law Enforcement (2 hours) De-Escalation and Minimizing Use of Force (2 hours)

Community Policing (2 hours)

All sworn personnel have completed federally mandated Incident Command System on-line courses IS 100, 200, 700, 800.

Officers Nauroth, Denney, and Scherr attended "Bullet Proof Mind" training in Rifle, CO, sponsored by the I-70 Training Group (tuition was free). This class presented ways the body and brain respond to stress during and after intense situations, in order to provide officers with coping mechanisms after such incidents.

Officer Scherr attended an 8 hour Advanced DUI Report Writing class in Florence, CO, sponsored by the Colorado Attorney General's Office.

Sergeant Crutchley attended a 30 hour Patrol Response to High Risk Situations class at Keystone, sponsored by the I-70 Corridor Training Group.

Mark Heminghous attended the annual Colorado Association of Chiefs of Police Conference in Grand Junction.

#### **Stats:**

All stats appear to be in line with current trends.

#### **Special Events:**

June 11<sup>th</sup> was the Dillon Airshow and June 18<sup>th</sup> was the Lake Dillon Brew Fest, followed by a concert. The Colorado Mounted Rangers were utilized to supplement the cadre of officers during those dates. Friday and Saturday night concerts were held on June 24<sup>th</sup> and 25<sup>th</sup>. There were no incidents to report from any of the events.

#### **Miscellaneous:**

Sergeant Crutchley completed the annual Colorado POST grant for training and equipment. The department received \$4,069.26 to cover hotel, per diem, tuition, and other associated costs for a ground fighting class for Sgt. Crutchley and an advanced sniper class for Officer Nance. The grant will also go towards our PoliceOnceAcademy.com account – an on-line training service that covers many of our basic training topics.

Sgt. Crutchley also wrote a 2016 Colorado Justice Assistance Grant, for which we were awarded \$5842.00. This money will be used for a permanent, solar powered, speed radar sign. This sign will be placed in an area where we can have a direct impact of the number, and severity, of traffic collisions in the Town.
